THE SCIENCE BARGE IS A FLOATING ENVIRONMENTAL EDUCATION CENTER POWERED BY SOLAR, WIND, AND BIODIESEL, VISITED BY MORE THAN 10,000 INDIVIDUALS IN 2018. IT WON BEST SCIENCE EDUCATION FIELD TRIP IN THE NEW YORK AREA, AND A FEDERALLY FUNDED EVALUATION SHOWED AN INCREASE OF MORE THAN 50% IN KNOWLEDGE RETENTION AMONG STUDENTS.
